

McLeod Health Has Announced its Intention to Build a New Hospital in Carolina Forest

McLeod Health has announced its intention to build a new hospital in the Carolina Forest area of Horry County.

"We have filed a Certificate of Need with the State, as required, demonstrating the need for a hospital in this location," said Monica Vehige, Administrator, McLeod Health.

"Pending approval from the Department of Health and Environment Control, our plans are to build a 4-story hospital with up to 48-beds on our 42-acre Carolina Forest campus, where we already have 2 outpatient buildings," said Vehige. "The ongoing development of services at the McLeod Health Carolina Forest campus is intended to offer coordinated services across the healthcare continuum and to address the need for value-based services to ensure good health for the residents living in Carolina Forest and Myrtle Beach communities."

According to the U.S. Census, Horry County is one of the fastest growing counties in South Carolina and Carolina Forest is one of the fastest growing areas of the county. Federal and state statistics demonstrate the need for additional beds in this area.

In the 2020 South Carolina Health Plan developed by SC DHEC, Horry County needs an additional 155 hospital beds by 2024. The need for general hospital beds is determined through the consideration of current utilization and projected population growth with the goal of having beds available within approximately 30 minutes' travel time.



"The current and projected population of Horry County, as well as the seasonal spikes we experience due to tourism is a major influence on the growing demand for healthcare services in our county," said Vehige. "Additionally, our current COVID-19 pandemic response demonstrated the insufficient hospital bed capacity in Horry County. Even without a pandemic, this shortage will become even more apparent as the population grows."

The addition of the hospital at this location will provide healthcare services needed by the local community and will be part of continued assessment of medical needs and recruitment of specialists and physicians to the area to serve patients and their families on the Coast.

"The planned \$56 million hospital will have 4 operating suites and will be available for patients



from our Carolina Forest Emergency Department that need continuing care," says Vehige. "Additionally, patients from this community, who have various illnesses or require surgery, will find care closer to their home."

McLeod Health demonstrated the strength of its health system, staff and resources during the current pandemic, maintaining excellence of care for our COVID and non-COVID patients. The new hospital will further bolster this regional strength for all our communities.

"This community's growth requires adequate hospital capacity to meet the growing demands for quality healthcare," said Rob Colones, CEO of McLeod Health. "Our mission is to improve the overall health and well-being of people living in the communities we serve."

> The Carolina Forest campus is envisioned to offer a wide range of health services that will provide the emergent, primary, specialty and inpatient care that patients need. McLeod Health will be the only healthcare system building a continuum of care, with specialty services at all three Horry County Hospitals – McLeod Seacoast, McLeod Loris and McLeod Carolina Forest campuses.

In existence since 1977, the McLeod School of Medical Technology has graduated 196 students from the program. A Medical Laboratory Scientist plays an important role in the prevention and diagnosis of diseases such as cancer and diabetes. They perform laboratory tests on specimens and in turn these tests assist physicians in verifying the causes of illnesses, aid in making medical decisions and in determining treatment options for their patients.

"This has been a very challenging but highly rewarding year for the graduates," said Dr. Sharon Mitchell, Program Medical Director. "This group is well prepared for whatever direction their career path leads them."

Both Todd and Lind were recipients of scholarship funds for the McLeod School of Medical Technology. These scholarships were made possible through generous donations to the McLeod Foundation.

This scholarship was established in 1991, in memory of Helen F. Bush, who worked in the laboratory for many years at McLeod Health. After her death in 1988 of cancer, her co-workers published the MRMC Laboratory Cookbook to raise funds to establish this scholarship in her memory.

All five graduates will be joining the McLeod Health team; four at McLeod Regional Medical Center and one at McLeod Health Loris.

As April Orange, Program Director for the McLeod School of Medical Technology remarked to the graduates, "I am proud of the skills they have gained by adapting to the situation we have all been placed under during a pandemic. They all stayed strong and now go forward as competent, successful Medical Laboratory Scientists."



The American College of Cardiology (ACC) recognizes McLeod Regional Medical Center for demonstrating expertise and commitment in treating heart attack patients. McLeod was recently awarded *the American College of Cardiology's NCDR Chest Pain – MI Registry*

Platinum Performance Achievement Award for 2020. McLeod Regional Medical Center is one of only 140 hospitals nationwide to receive the honor. McLeod also achieved Platinum Performance status in 2019.

This award acknowledges the commitment of McLeod to their success in implementing a higher standard of care for heart attack patients and in reaching an aggressive goal of the principal levels of care as outlined by the American College of Cardiology/ American Heart Association clinical guidelines and recommendations.

To receive the Chest Pain – MI Registry Platinum Performance Achievement Award for two consecutive years, McLeod demonstrated sustained achievement in the Chest Pain – MI Registry for 36 straight months, and performed at the highest level for specific performance measures. Full participation in the registry engages hospitals in a robust quality improvement process using data to drive improvements in adherence to guideline recommendations and overall quality of care provided to heart attack patients.

The Chest Pain – MI Registry empowers health care provider teams to consistently treat heart attack patients according to the most current, science-based guidelines and establishes a national standard for understanding and improving the quality, safety and outcomes of care provided for patients with coronary artery disease, specifically high-risk heart attack patients.

"There were 10,460 heart disease deaths in South Carolina in 2018 according to the Centers for Disease Control," said Dr. Alan Blaker, Executive Medical those, 5,215 would be considered deaths from a heart attack. This is why, as an accredited Chest Pain Center, the outstanding care McLeod provides heart attack patients is so important.

"Hospitals that are Chest Pain accredited emphasize the importance of standardized diagnostic studies, effective evaluations and rapid treatment for all patients with chest pain and other heart attack symptoms," added Dr. Blaker.

As an accredited center, McLeod is recognized for having a higher level of expertise in caring for patients who arrive in the Emergency Department

with heart attack symptoms. It also ensures that, as new research becomes available, we continue to operate at the highest level, with best practices, to care for cardiac patients.

Chest Pain Accredited Hospitals utilize standard diagnostic studies, effective evaluations and rapid treatment for all patients with chest pain and other heart attack symptoms. The McLeod Chest Pain Center also serves as a point of entry into the healthcare system to evaluate and treat other medical conditions, helping promote a healthier lifestyle to reduce the risk factors for heart attack.

Chest pain is the number one symptom of a heart attack. Sometimes the pain comes and goes quickly, and sometimes it is a dull but persistent sensation, but it's always something that should be checked. The American Heart Association lists the following common signs and symptoms you should know:

- Pain in the chest, shoulders, neck, arms or jaw
- Pressure or discomfort in the chest
- Sweating
- Nausea
- Shortness of breath
- Fainting
