Family, healthcare and the power of philanthropy have guided Beth Ann and Marvin Owen in their establishing of a legacy commitment to the McLeod Health Foundation.

For Beth Ann and Marvin, generosity and service go hand in hand. This dedicated couple shares their wisdom, leadership and generosity in support of a variety of programs and services funded by the Foundation.

Marvin literally grew up around McLeod as his father, the late Dr. James Owen, was a muchloved OB-GYN. His plans were to pursue his father's career path until he observed his first

cesarean section. Fortunately, he quickly changed his major to computer science, helping to found ACS Technologies in the late 1970s.

Beth Ann recalls her first memory of McLeod when she witnessed the excitement of her father-in-law on the day the hospital moved from the original infirmary location to McLeod Regional Medical Center in 1979.

Experiences with their own children and Beth Ann's career as a pediatric nurse also led to close connections with the McLeod Children's Hospital. Marvin and ACS have been longtime sponsors of the Children's Hospital Golf Classic,

and Marvin currently serves as the Chair of the Golf Committee. He also previously served on the McLeod Foundation Board of Trustees.

In 1996, Beth Ann's family experienced hospice care with her father, John Kenney, in Charlotte. In 2015, her mother, Ann Kenney, also received hospice care while under the care of a nursing home facility. Following these experiences, Beth Ann and Marvin became McLeod Hospice Tree Lighting Sponsors to support the program that helped so many like her parents.

"As a nurse by profession I knew what hospice was," says Beth Ann. "But I did not become closely involved with hospice until my father was diagnosed with pancreatic cancer."

Beth Ann's parents were fortunate to have insurance and the financial means to cover unforeseen needs during their illnesses, but many other patients are in difficult situations and see those unanticipated needs go unmet. Honoring and remembering this care, Beth Ann volunteers her time with the McLeod Hospice program. She currently serves as the Chair of the Butterfly Fund Advisory Committee.

In 2022, Marvin's beloved mother, Helen Owen, was cared for by McLeod Hospice at the time of her passing.

"My parents' story was a Florence story, a McLeod story and, like any good story, it's a love story," explains Marvin.


Helen and her husband, James, first met while working in the McLeod Emergency Department. She was a nursing student, but once they married, she settled into taking care of the family so her husband could focus on his work as one of Florence's first OB-GYNs.

"After a stroke, she had a brief visit to the hospital but spent her last days at the McLeod Hospice House, which was so wonderful," Marvin shares about his mother. "Everybody here knows the value of McLeod Hospice, and that is why we support it."

The Owens strongly believe in giving back to their community and it was because of these family experiences that Beth Ann and Marvin decided to establish a McLeod Hospice Tree Lighting Endowment.

Gifts That Require No Money Today
