Coastal Cancer Care Benefits from Their Generosity

For Judy Wooten, her family's cancer journeys have influenced the direction of her life.

Judy grew up an only child in the Longs/Loris area of South Carolina. She began her career working at Horry Georgetown Technical College (HGTC) and married her first husband, Stuart. Years later, she was devastated to learn of her husband's diagnosis of lung cancer which had metastasized to his brain and bones.

Judy was only 33 years old when Stuart passed away, and she struggled to go on emotionally. With the help of her loving parents, she went back to school to obtain both her undergraduate and master's degrees. Judy returned to HGTC working her way up to the position of Associate Vice President of Human Resources and retired after 42 years of service.

During her tenure at HGTC, Judy learned of her beloved mother's diagnosis of ovarian cancer. It was heartbreak when she passed away after only 10 months.

As God's plans are often better than we can ask for, Judy was introduced by a cousin to Pat Wooten, a Real Estate Broker and Auctioneer from Whiteville, North Carolina. They discovered they had similar values, and the couple married the following year.

The Wooten's loving relationship spills over with their focus on helping others. The McLeod Health Foundation is blessed by their generosity.

Pat has a heart for mission work and has taken many trips over the years. "I am so blessed and there is no greater feeling than to see God at work and participate in what he is doing," explains Pat.

Judy's personal experiences with cancer guide her service on the McLeod Foundation's HOPE (Helping Oncology Patients Everyday) Committee. She has also previously served on the McLeod Health Foundation Coastal Board.

"When I hear the stories during the HOPE meetings, it is so eye opening, and it motivates me to want to give more," offers Judy.

Kelvin and Tracy are incredibly grateful for the high-quality cancer care which is a priority for McLeod Health. They have generously supported the McLeod Health Foundation through the Employee Campaign for more than a decade. Now, through this very personal family experience, they have made a significant commitment in their estate plans to continue excellent cancer care for future generations.

"When our family faced our greatest crisis, we were supported by a strong faith and knew we were surrounded by caring and competent healthcare professionals," explains Kelvin. Bullock Family Brings Values of Service to the Pee Dee

Gunter Bullock's relationship with his family instilled his values of giving back by devoting time to important causes. Fortunately for the Pee Dee, his professional life led him to our region.

Gunter grew up in Thomasville, Georgia, where he found his passion for community service in high school. While obtaining his undergraduate degree in Biology at the University of Georgia, he volunteered at the local indigent healthcare clinic and spent his summers working at his Uncle Dennis Wheelus' nuclear pharmacy in Florence, South Carolina.

This experience led him to attend the Medical University of South Carolina's College of Pharmacy to study Nuclear Pharmacy. While there, he met his wife Emily, and they married in 2016. He continued his focus on helping others by serving on three medical mission trips to Nicaragua.

His Uncle Dennis opened Pee Dee Isotopes in 1993 and provided nuclear medicine services for McLeod Health and the surrounding region. The business was eventually sold in 2007. However, in 2015, Gunter, Dennis, and Casey Hydro reopened the business to bring back quality

nuclear medicine service to McLeod Health. The business is now called PDI Pharmacy Services.

For Gunter and Emily, Florence is home for their expanded family which includes three young children. Emily is a clinical staff pharmacist in the inpatient and pediatric pharmacy in the McLeod Children's Hospital. "It is truly a blessing to have access to this amazing facility," shares Emily.

The young couple began their relationship with the McLeod Health Foundation by joining

Harsh lights, beeping equipment, caregivers bustling in and out -- hospitalization is stressful for most adults. But imagine this from a young child's perspective: sick, in pain, and removed from everything familiar. However, thanks to generous gifts to the McLeod Health Foundation, the McLeod Children's Hospital Child Life Program has been making hospital stays easier, more kid-friendly, and even surprisingly fun at times.

Cory Prescott, McLeod's Child Life Coordinator, guides and reassures patients and their families in the Pediatric Intensive Care Unit and on the Pediatric Floor. "Positivity is our goal," Cory says. "Providing a comfortable and stress-free space makes their stay feel less like a hospital and more like a hotel with fun toys and activities."

Maggie Bellflowers experienced the ongoing evolution of the Child Life Activity Center when her son Owen, a kindergartener at the time, was hospitalized with three highly contagious viruses.

"The playroom was like being in the Hilton," Maggie remembers. "His eyes grew three sizes when he saw it. He gasped, 'Mama, I want to go there!'"

Although in isolation in his own room, Cory and her staff brought the Child Life Activity Center to Owen.

"He felt so much love and compassion," Maggie continued, "Owen got to choose the toys he wanted to play with: a teddy bear, coloring books, a comfortable blanket, and his favorite: a Spider Man playset to keep. I was blown away and said, 'Do you spoil every patient like this?' Cory smiled and said, 'Yes. Yes, we do.'"

What started out as overwhelming became calm. "My anxiety about my young child melted away," Maggie said. "It was such a relief to hear him say, 'Mama, I don't need you. I'm fine here with the nurses.'"

Even when it was time to remove his IV port, which Owen was apprehensive about, Cory calmed his fears.

NASCAR Foundation Provides Grant for Child Life Activity Center in the McLeod Day Hospital

The NASCAR Foundation is a shining example of how donors further assist pediatric patients at McLeod. They recently provided a grant to create a separate Child Life Activity Center in the McLeod Day Hospital for outpatient pediatric surgery patients. The center provides an environment where children can engage in fun activities prior to surgery, reducing anxiety for both the child and family.

"This grant has transformed a somewhat sterile playroom into a fun and joyful one," Cory added.

"A child's experience with the medical world sets the tone for how they view and use healthcare services for the rest of their lives," says Cory. "Our donors help us transform the idea of what a hospital can be."

And today the treasured Spiderman playset is still in Owen's bedroom at home.

Chapin Foundation Continues Generous Vision


Giving Every Child a Chance to Thrive Brings Hope to Families

Thanks to Simeon B. Chapin, who established the Chapin Foundation in 1943, the quality of life in Myrtle Beach has been greatly enriched. His legacy continues to guide the Foundation today as it partners with organizations like McLeod Health.

This year, the visionary businessman's legacy is touching the lives of children suffering the effects of disease, injury or disability through a \$90,000 grant for pediatric rehabilitation equipment at McLeod Health Carolina Forest's Pediatric Rehabilitation department.

Chapin's legacy is evident with the specialized care McLeod provides for children like Enrique "Kiki" Alvarez. He is one of the many beneficiaries of this generous man's vision of providing access to high quality care for the most vulnerable of Myrtle Beach.

At just 22 months old, Kiki lights up every room with his curious spirit and contagious giggle. But, behind his joyful demeanor, Kiki's parents began noticing something that tugged at their hearts -- he wasn't speaking like others his age.

Coming from a bilingual household, his parents initially wondered if the delay was simply part of navigating two languages. But their instincts told them something more was happening.

Fortunately, they acted upon their instincts and turned to McLeod Pediatric Rehabilitation, where Speech-Language Pathologist Jennifer McKevitt began working closely with Kiki.

A key part of Kiki's journey has been the use of specialized therapy tools and sensory equipment made possible by the Chapin Foundation grant.

Today, Kiki is making remarkable strides. He is beginning to use small words, imitate sounds and communicate through signs.

"We are still waiting for him to say those precious words of 'mama' and 'dada' – but he's getting closer every day," Kiki's mom Lizeth shares with tears in her eyes.

Kiki's story is a testament to the power of early intervention, compassionate professional care and community generosity. Thanks to the Chapin

Foundation's support, McLeod Pediatric Rehabilitation on the Carolina Forest campus continues to offer children like Kiki the tools they need to thrive and the hope their families embrace.

Tory Mackey, Executive Director of the Chapin Foundation, reflected on Chapin's vision: "We are continually inspired by the vision Mr. Chapin had for Myrtle Beach and how he identified critical areas that have stood the test of time. From the board to the staff, we all have an incredible sense of calling -- that is what keeps us going."

For families like Kiki's, the Chapin Foundation's investment means more than equipment. It represents hope. It reflects a belief that every child deserves the chance to thrive, to overcome obstacles, and to step into a brighter future.

Baker Tange had a great start in life when she was born at McLeod Regional Medical Center. Growing up in Florence and eventually marrying another Florentine, Chad Tange, Baker is firmly devoted to this community.

She began her relationship with the McLeod Health Foundation by attending a Circle of Excellence Sunday Funday. The Circle of Excellence is a young giving society organized through the McLeod Health Foundation. One month later, Baker learned that her father, Rich Reynolds, had suffered a massive stroke. While some suggested moving him to Columbia or Charleston, Baker confidently encouraged him and her stepmother to remain at McLeod Regional Medical Center for his care. After making miraculous strides in the Intensive Care Unit, her dad was discharged and continued his therapy at the McLeod Outpatient Rehabilitation Center.

"I am really passionate about McLeod Health and the ways I can serve our community through my volunteering. The years I spent getting involved through McLeod Fellows and the Circle of Excellence gave me the confidence in McLeod I needed when my parents faced medical crises," shares Baker.

For Baker and her family, frightening health crises gave them a new appreciation for the value of excellent local healthcare. Baker's knowledge of the quality of care available at McLeod also helped her guide their wise medical choices including a recurrence of Cely Anne's cancer.

"Knowing that your community has your back when it matters most is incredible," explains Baker.

Baker Tange is grateful for the excellent, compassionate care delivered to both of her parents at McLeod Regional Medical Center.

"I got to see firsthand how powerful the mission of McLeod Health really is."




